### **1. RULES**

The Race will be governed by the 2009-2012 Racing Rules of Sailing (RRS) and The Leukemia Cup Regatta Sailing Instructions, which will be available at the Skippers Meeting. New Orleans Yacht Club (NOYC) and Southern Yacht Club (SYC) will administer the Race.

### **2. CLASSES**

PHRF: Spinnaker, Non-Spinnaker and Multi-Hull. Class breaks will be defined at the Skippers Meeting.

### **3. RACE FORMAT & LOCATION**

All racing will be conducted on custom courses with fixed or temporary marks on the South Shore of Lake Pontchartrain approximately one (1) nautical mile north of the host clubs.

### **4. ADVERTISING**

The regatta is designated Category A in accordance ISAF Regulation 20 for all classes. Racers may upgrade to Category C which allow advertising if their boat raises \$250 or more; there will be no additional entry fee for Category C.

### **5. ELIGIBILITY**

Competitors: The race is open to all. Competitors need not be a member of a yacht club.

Boat: Participating PHRF boats must have a current GYA PHRF certificate. Boats without a current GYA PHRF certificate will be assigned a rating based upon similar boats. The assigned rating cannot be protested.

### **6. ENTRY FEES**

The Entry Fees shown are the minimum amount required to participate in the event. Additional donations for this worthy cause are encouraged and will be recognized.
